The aim of the Summer camp week is for all the students (and teachers!) to have fun and to get a taste of the performing arts by taking part in a variety of classes that could include acting, singing and of course different styles of dancing. Your child will be taught by qualified and highly experienced teachers/choreographers or performers. We also have assistants for the younger groups.

Please note -Miss Karen's annual dance camps and workshops will now operate under the name of The Bucks School of Dance. It is still managed and organised by Karen Stuart, who started KSA Dance camps over 15 years ago. Dance camp students do not need to already attend The Bucks School of Dance as dance camp is inclusive to anyone who loves dance.

The course will run from Monday 19th August– Friday 23rd August at Berkshire Agricultural College for children aged 5+. Each day will start at 10:00 and finish at 4:00. The end of the week the students will perform a show and parents are encouraged to come along for this. Showcase details will be sent nearer the time, but it is usually around 2.15 -3.30 on the Friday.

The cost of the 5 day course is £135 per child, with a 20% reduction for any additional siblings. This includes a medal, t shirt, certificate, and of course expert tuition throughout the week. **All places will be given on a first come first served basis so please be quick!!!**

Please provide your child with a packed lunch and plenty of drinks each day. They need to wear comfortable clothes, which are suitable to dance in and bring any dance shoes they have e.g. Ballet, Tap, Modern/Jazz shoes and PLEASE make sure ALL clothes and shoes are labelled. (If your child doesn't have tap shoes-please bring non-rubber soled shoes e.g. school shoes). We may be outside at lunchtime so please advise a sunhat.

Please note - We do not accept childcare vouchers and all cheques should be made payable to The Bucks School of Dance Ltd. I give permission for my child to participate in the Summer dance camp. If my child has a medical condition/allergy or injury I will supply full details of this and advise on a care plan to follow during camp.

I acknowledge that in cases of extreme weather which results in the teachers not being able to attend the camp; the whole camp or part of the camp may be cancelled, and a Dance Camp Voucher may be issued.

I understand that my data will be kept in accordance with the 2018 GDPR guidelines. I have the right to be forgotten and must inform Karen Stuart if I no longer wish to be contacted about future workshops. I understand that if I wish for my data to no longer be kept by The Bucks School of Dance after the camp, that I should inform Karen Stuart via email of this request.

The Bucks School of Dance will use your email address and your emergency contact number to contact you during the camp or workshop should we need to, and we will keep your name, number and email address on file to inform you of future dance workshops/camps. You will not be added to our dance school mailing list unless you attend regular classes with us.

We need to keep your child's name, date of birth, contact number, parent's email address and also any medical conditions on file for safeguarding reasons. All registration forms are destroyed at the end of camp.

I understand that any photos/videos taken by our photographer (Ken Smith-Karen's Dad) or by Miss Karen may be used for promotional purposes including our social media pages. We will not tag you or your child in photos or list their names with their photos or videos. If you do not want your child to be included in any of our photos shown on social media or our website you must inform K stuart via email at least 2 weeks before the start of camp.

Parents are allowed to video their child at the showcase at the end of the week and we ask you to keep these for personal use only as you may not be aware of any children that have opted out of being in any videos or photos etc. If you have any videos or photos you would like to share with us please send them directly to Karen and she can check them before posting them on SOCIAL MEDIA.

I am aware that parents will be allowed to take photos and video the showcase on the final day of camp. If I object to this and do not want my child to be videoed at the show, we would need to tell all parents that they cannot video the showcase.

If that is the case for any of our students, we will video the rehearsal only without that child being in it and share these via social media. Please inform us 2 weeks prior to the showcase if you do not want your child to be in any video footage of the showcase.
